1. Densholme Care Farm will ensure adequate resources both time and money are made available to the necessary people to ensure that the items listed above are implemented and all employees are provided with the necessary instruction, information, training and supervision to enable them to carry out their work without risk to themselves or others. An annual review of the Health and Safety Policy will also be undertaken to ensure it is relevant to the work being undertaken by the Farm and all legislation quoted is up to date, where necessary the policy will be developed and expanded.
5. Densholme Care Farm is also committed to the continuous development and improvement of the Farm's health and safety management system. The Farm will ensure that the health, safety & welfare of any employee or subcontractor is not compromised for financial or commercial gain.
6. All employees of the Farm agree, as a term of their contract of employment, to comply with their individual duties under the Health and Safety at Work Act 1974, and the Management of Health and Safety Regulations 1999 and other legislation, and to generally co-operate with the Farm so as to enable it to carry out its duties towards them.
