BOOKING TERMS AND CONDITIONS

Your party booking is with Densholme Farm Action. Your booking is confirmed when we have received your £20 refundable deposit. **Final payment is due 7 days before the party date.** We must receive written notification if you wish to postpone or cancel your party.

We aim to ensure that all descriptions on our booking form are accurate. We will notify you of any changes before you confirm your booking. Densholme Farm Action reserves the right to alter or withdraw any party or service.

The parent or caregiver is responsible at all times for the supervision of children whilst on site including all areas of the farm that are made accessible by the Farm Manager. Our responsibility is strictly limited to the facilitation of party activities provided by us. It is not the responsibility of Densholme Farm Action to supervise the party.

Parents/ guardians should note that while every consideration has been given for the safety of children using the farm facilities, Densholme Farm Action cannot be held responsible for accidents which occur as a result of children playing on the equipment or using the facilities. We would ask customers to report any accidents before leaving the farm please.

The classroom and all surrounding areas must be left clean before you leave the farm. If the standard is deemed not satisfactory by Densholme Farm Action then a fee for cleaning will be deducted from your deposit.

Clothing and footwear suitable to the chosen activities must be worn.

Please note we are unable to provide any refund for bad weather so please consider a wet-weather contingency plan.

COVID-19 SAFETY INFORMATION:

When hosting a party at Densholme Farm 'social distancing' must be practiced and face coverings worn at all times whilst indoors to reduce the risks of exposure to COVID-19. All visitors including children must sanitize their hands upon entrance to the farm and follow the precautions put in place. Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, Densholme Farm has put in place preventative measures to reduce the spread of COVID-19. However, Densholme Farm cannot guarantee that parents/carers, volunteers, children, or others attend the party will not become infected with COVID-19.

In light of the ongoing spread of COVID-19, individuals who fall within any of the categories below should not attend the farm. By hosting a party at Densholme Farm, you certify that you and party attendees do not fall into any of the following categories:

1. Individuals who currently or within the past fourteen (14) days have experienced any symptoms associated with COVID-19, which include fever, cough, and shortness of breath among [others](#);

2. Individuals who have travelled at any point in the past fourteen (14) days either internationally or to a community in England. that has experienced or is experiencing sustained community spread of COVID-19; or

3. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19.

LIABILITY

Densholme Farm Action shall not have any liability to the client for any loss, damage, costs or expenses which the client suffers or incurs arising out of the event unless arising out of gross negligence or willful misconduct of Densholme Farm Action, its employees or suppliers.

The client undertakes to indemnify and keep indemnified Densholme Farm Action in respect of any damage to property or any other loss of any nay nature whatsoever that Densholme Farm Action may suffer as a result of any act or omission of the client or its guests as the event.

Accidental damage to the property at the event shall be deducted from the deposit. Densholme Farm Action hereby excludes any liability for any such loss. Densholme Farm Action does not accept any liability and shall not be liable for non-completion of the event or for any delays arising as a result of 1) Bad weather or 2) Loss, damage or cancellation due to fire, floods or any other cause beyond its reasonable control. Should a Covid-19 lockdown be enforced all deposits will be returned.
